
### **Did You Know?**



The largest trash incinerator in the U.S. is located in Chester, PA!

6.1 square miles - 34,000 residents, and is also home to a sewage treatment plant and sewage sludge incinerator, chemical manufacturing plants, a paper mill, and other polluting industries.

Over a century of systemic racism and political corruption has transformed the historic waterfront city on the Delaware River into a regional toxic waste hub and ONE OF THE WORST CASES OF ENVIRONMENTAL RACISM IN THE U.S.


### Some Fast Facts While You Fill Out The Survey

- 1. Particles from an incinerator can travel miles from the stacks, depending particulate size and winds.
- 2. There are nearly 20 significant polluters in and near the Chester waterfront
- 3. Roughly 35,000 people live within 1-2 miles of the incinerator.
- 4. Chester's childhood asthma hospitalization rate is 3 times the Pennsylvania average.






### Waste Producers Along Chester Waterfront

### The Why of Incinerator Location



Larger perspectives - environmental racism, zero waste, plastics, corporate messaging, fact-checking

Why is Covanta in Chester? Which communities are most affected?

Where are they typically located?

Why are these populations affected?

Incinerators and toxic companies target low-income areas and communities of color because they are seen as the path of least resistance.

Polluting industries have led to devastating consequences on community health and quality of life for majority low-income black and brown communities like Chester.

Answer: A Zero Waste (ZW) System


Does two things: Redesigns our systems and resource use AND captures discards and uses discards to make new products.

#### **TIPS & TRICKS FOR PLASTIC RECYCLING**



Keep lids on bottles or toss them in the trash — they're too small to recycle by themselves



Rinse and dry all food and drink containers



Detergent containers are fine, just be sure they're free of soapy residue

No plastic bags — check with your local grocery store for alternative recycling options



No plastic wrappers from food or packaging



No bubble wrap, packing peanuts, or foam packaging
