If your request is approved, we cannot approve an identical case in future years. This form cannot be used to reevaluate Pennsylvania state grants. Any documentation requested is necessary and must be submitted for evaluation so that each request may be Considered fairly and consistently. Please allow a minimum of ten working days after all documentation has Been received for an appeal decision.

- ☐ Unemployment, change in employment, or loss of benefit (Social Security or Child Support)
 - Submit letter from employer, termination letter or DD214, final pay stub with year-to-date summary (including gross wages) and 2023 and 2024 federal tax return transcript – must be at least 10 weeks from loss of employment.
 - Submit letter from Social Security Administration, or Form 1099 for 2023 and 2024, or a divorce decree that indicates when child support ends and a 2023 and 2024 federal tax return transcript.
 - ☐ Marital status change
 - Submit divorce decree/separation agreement if legally separated. Submit a 2023 and 2024 federal tax return transcript, utility bills or lease/mortgage documents with different addresses for each party.
 - Submit a marriage certificate if you married after you completed the 2025.26 FAFSA. Submit a 2023 and 2024 federal tax return transcript for yourself and your new spouse.
 - ☐ Death of student's parent or spouse resulting in reduced household income
 - Submit documentation such as death certificate. Provide a 2023 and 2024 federal tax transcript.
 - ☐ Medical expense – large medical debt not covered by insurance. (Not Cosmetic Procedures)
 - Submit a 2022 and/or 2023 federal tax return transcript, including all schedules. Submit copies of canceled checks and/or statements showing expenses that were paid in 2023 and/or 2024. Do not include any premiums paid for your medical insurance.
 - ☐ One-time income distribution (inheritance, moving expense allowance, back year social security payment, or IRA/pension distribution)
 - Provide documentation to identify the source of income and a 2023 and 2024 federal tax return.
 - ☐ Other Significant Expenses – not included in current FAFSA information (Elementary/Secondary Education, Disabled/Elderly Dependent Care, etc.)
 - Documentation detailing costs, proof of payments, and current tax record with schedules.
 - For education costs- school documentation on their letterhead
 - ☐ Tuition – sibling(s) enrolled in another college/university- the additional costs create family hardship.
 - Must provide 2024 tax records.
 - Must provide Financial Aid Package from other school(s)
 - Will need to provide Confirmation of Enrollment- form/letter from other school. *
 - Billing Statement from other school(s)*
